

Many have enjoyed the annual Downtown Tinley Boo Bash. The 2020 Boo Bash, like many other things, will look different this year in order to comply with Illinois' Phase 4 outdoor event guidelines. With these changes, this event will allow children to trick or treat with local businesses and have Halloween fun in a safe environment.


All families will need to pre-register for this event. The new Boo Bash will guide multiple groups of 50 participants through each activity station which will include dancing, a juggler, a magician, costume parade, slime, crafts, and trick or treating with participating businesses. Each group will remain at every activity stations for 5-8 minutes depending on the activity.

Business BOOths will be grouped in stations which will be assigned by event staff. Each business BOOth is required to provide it's own masks and gloves for every person at the booth which must be worn the entire time. Candy and promotional material will need to be passed out by a gloved and masked individual. There should be no items available for little hands to grab. **Each BOOth must supply enough candy for at least 750 children.** Sales pitches are discouraged at this event because each station is limited on time. Please have candy and promo items ready to drop in a bag when the children arrive at your booth.


Each Business BOOth will receive a 10x10 area to set up a table. BOOths will be expected to be operational by noon and no cars will be allowed in the parking lot after 11:30 a.m. Pop-up tents must be weighted down. Tents that do not comply must be taken down before the start of the event. Canopy weights can be found at Menards. Sandbags are also acceptable.

Sponsorship opportunities are available to Tinley Park Businesses until October 8th. If space is available after that date, sponsorships will be made available to businesses outside of Tinley Park.
