- CFL Bulbs
- Fluorescent Tubes
- Miscellaneous Mercury Items
- Ballast Sodium Bulbs
- Used Antifreeze
- Used Motor Oil
- Hydraulic Fluid Metal
- Batteries

**ITEMS ALLOWED IN THE TRANSFER STATION:**

Household Trash: *Must be generated within the Town of Waterboro*

**RECYCLING CONTAINER:** Items allowed are: Newspapers, Glass, Telephone Books, Plastic, Cardboard, Soft Cover Books.

NOTE: *This changes as the recycling market changes.*

**CONTAINERS:** Items allowed in the containers: painted wood and treated wood, metal/white goods, asphalt shingles and sheetrock.

*We will accept paint cans. Paint disposal is free.  
Do not use paint dryer or cat litter.*

**ITEMS NOT ACCEPTED:**

Contaminated Oil, Pesticides, Any Toxic Materials, Chemicals, Acids, Caustics, Septic Materials, Asbestos, Gasoline or Any Other Flammable Liquids, Any Solvents.

**SWAP SHED:**

No items are to be removed for resale unless they have remained there for 2 weeks. No televisions, microwaves, mattresses, cribs, car seats or other baby equipment will be accepted for the swap shed.

**Penalties for violators will be as follows:**

- 1<sup>st</sup> Offense - 30 Day Suspension of Transfer Station privileges
- 2<sup>nd</sup> Offense - 6 Month Suspension of Transfer Station privileges
- 3<sup>rd</sup> Offense - 1 Year Suspension of Transfer Station privileges

**\*Beginning July 1, 2024 the price for a permit will increase to \$50.00**

**METAL IS NOW BEING ACCEPTED AT NO CHARGE**



1. **No one will be allowed to use the Transfer Station without a current Sticker and or Laminated Pass!**
2. **Stickers:** Stickers must be adhered to the lower left hand corner, of the driver's side, front windshield. If an inspection sticker is located in the area, the Transfer Station Sticker may be placed either below or above said inspection sticker. If you cannot plate the sticker in this area, the Transfer Station sticker may be adhered to the right of the inspection, as per Title 29-A §2082.
  - The cost for a Sticker is \$10.00 for the first, and \$6.00 for any additional stickers within the same household. **\*Beginning July 1, 2024 stickers will be \$20.00 for the first, and \$10.00 for any additional stickers within the same household. Residents who are 65 or older will pay a rate of \$10.00 per sticker\***
  - Lander Owners, who do not have a dwelling on their land, may obtain a sticker.
  - **Laminated Passes:** The cost for a Laminated Passes is \$20.00. **\*Beginning July 1, 2024 hand carried passes will increase to \$40.00\*** Laminated passes must be presented to the attendant before using the Transfer Station. These passes are purchased at Town Hall ONLY. A copy of a tax bill, vehicle registration and or other records displaying ownership must be provided. **Laminated passes offer the same service(s) as the stickers.**
  - Residents have the option to obtain either a sticker, or a laminated pass for their property.
  - Residents using a company vehicle will be required to obtain a Laminated Pass for their vehicle.
  - Cottage(s) & Camp(s) that are seasonally rented will be required to obtain a Laminated Pass. These passes must be obtained by the property owner and not by the renter(s).
  - Properties identified as a trust will be required to have a hand carried pass.
  - Churches may obtain a hand carried pass at no charge.
3. **Commercial Hauler Permit:** All commercial haulers are required to purchase a Commercial Hauler Permit (\$100.00 yearly/\$25.00 daily) in addition to being charged for tipping fees, which must be presented upon entering the facility and prior to disposing of garbage. *Such permits are non-transferable.*
4. The Transfer Station will be closed when the following holidays fall on a regularly scheduled workday: Christmas, New Year's Day and Easter or on any other day designated by the Selectmen.
5. Storm closures will be posted on Channels 6, 8 and 13 and on the Town website, www.waterboro-me.gov along with other Town Department closures.
