It is the responsibility of the applicant to ensure that all installations are in full compliance with applicable statutes of the State of Iowa any local and Federal Code Ordinances.

TWO SETS OF PLANS shall accompany this application. The plans shall include a site plan, drawn to scale, showing the location of property lines, the proposed tank location, dispensing area location, any buildings/structures, any existing tanks, vehicle access, power lines and other utilities, on-site fire protection (ex. Fire hydrants), vehicle impact protection, and any hazards within and near the area.

The plans shall include but not be limited to, indicate the type of tank (manufacturer's information sheets, details of tank design and construction, dispenser design information, location and classification of electrical equipment (including lighting of area), emergency fuel shutdown devices, product MSDS's, List of listed parts, venting, plans for secondary containment, valves, piping, tank and secondary containment capacities, fire extinguisher size and location, and signage display. The Plan Review Information Sheet (first page of this packet) shall be completed and returned with the plans along with the appropriate plan review fee. No work is authorized prior to approval from Waterloo Fire Rescue Inspections Department.
