Event Details: May 5th 2018

Street Closures:

- Requesting streets to be closed at 9:00 a.m. 12 midnight See attached map.
 - o Sycamore Street from Biddle to Yack Area Parking

Overview:

A free event for all ages to celebrate Cinco De Mayo. Live music, entertainment, and dancers. Vendor booths, food booths and bar. The event will take place from 1p.m. – 10p.m.

City Requests:

- 4' chain link fence and / or freestanding green fencing to go around the event space.
- "No Parking on Saturday" signs to be placed on Sycamore on Friday
- Access to water to fill tent water barrels and food vendors.
- Electrical is needed (more details to follow closer to the event)

BE IT FURTHER RESOLVED that WOW 360 will comply with the following:

- That any costs, overtime or otherwise, for any city staff/material/property for said event will be the responsibility of the WOW 360 with fees payable no later than 14 days following the event.
- Any tents on the street or sidewalk must be weighted (no stakes are allowed to be used to anchor tents) to prevent collapse.
- WOW 360 will be responsible for clean up (glass, spills, broken items, etc.) before, during, and after the event.
- Any requests made after this letter is reviewed and approved will be evaluated by the Special Events Coordinator and necessary Department Heads for approval/denial.

BE IT FURTHER RESOLVED that the WOW 360 must add the City of Wyandotte as additional insured to their insurance policy and sign a hold harmless agreement as prepared by the Department of Legal Affairs.

2018-179 PROPOSED CHARTER AMENDMENTS – COUNCIL MEETING TIMES

BE IT RESOLVED, by the City Council of the City of Wyandotte, Michigan, as follows:

1. The City Council by at least three-fifths votes of its members-elect, pursuant to the authority granted by Act 279, Public Acts of Michigan, 1909, as amended, proposes that

Section 5 of the Chapter VI of the City Charter of the City of Wyandotte, shall be amended to read as follows:

Chapter VI City Council

Section 5. Regular Meetings; Special Meetings; Meetings to be Public

The city council shall meet in a regular session at the council chambers in the city hall, at least two (2) times each month at times and dates to be determined by city council for the purpose of receiving communications, complaints, petitions and reports, holding public hearings, discussing pending matters, and deliberating toward and rendering decisions on all public policy. The mayor or any three (3) members of the council may call special meetings thereof, notice of which, in writing shall be given to each member of the council, or left at his place of residence, at least eighteen (18) hours before the meeting. All meetings of the council or any committee shall be public and in compliance with the open meetings act.

The existing Section 5 of the Chapter VI of the City Charter of the City of Wyandotte to be altered by such proposal, if adopted, now reads as follows:

Chapter VI City Council

Section 5. Regular Meetings; Special Meetings; Meetings to be Public

The council shall meet in regular session, at the council chambers in the city hall, at least once each week as a committee of the whole, for the purpose of receiving communications, complaints, petitions and reports, holding public hearings and discussing pending matters and shall meet in regular session at least once each week, in the evening. The mayor or any three (3) members of the council may call special meetings thereof, notice of which, in writing, shall be given to each member of the council, or left at his place of residence, at least (12) hours before the meeting. All meetings of the council or any committee thereof shall be public.

2. The proposed amendment to Section 5 of Chapter VI shall be submitted to the electors in the following form:

WYANDOTTE CITY CHARTER AMENDMENT

Ballot language shall read as follows:

Shall Section 5 of the Chapter VI of the City of Wyandotte Charter be amended (1) to require the City Council meet at least twice a month instead of the current requirement of once a week, (2) to require 18 hours notice for special meetings instead of 12 hours notice, and (3) to acknowledge that meetings of the City Council and its committees must comply with the Open Meetings Act?

- 3. The City Clerk shall transmit copies of the proposed amendment of Section 5 of Chapter VI of the City Charter to the Governor of the State of Michigan for approval, and transmit a copy of the foregoing statement of purpose of the proposed amendment to the Attorney General of the State of Michigan for approval, as required by law.
- 4. The proposed charter amendment of Section 5 of Chapter VI shall be, and the same is hereby ordered to be, submitted to the qualified electors of the City of Wyandotte at a special election in the City of Wyandotte Election to be held on the 7th day of August, 2018, and the City Clerk is hereby directed to give notice of the election and notice of registration thereof in the manner prescribed by law and to do all things and to provide all supplies necessary to submit the charter amendment to the vote of the electors as required by law.
- 5. The proposed amendment of Section 5 of the Chapter VI shall be published in full together with the existing charter provision altered or abrogated thereby as part of the notice of election.
- 6. The canvass and determination of votes of said questions shall be made in accordance with the laws of the State of Michigan and the City Charter of the City of Wyandotte.
- 7. All resolutions and parts of resolutions insofar as they conflict with the provision of this resolution be and the same hereby are rescinded.

2018-180 PROPOSED CHARTER AMENDMENTS - APPOINTED ASSESSOR

By Councilperson Maiani, supported by Councilperson Schultz

BE IT RESOLVED by The City Council of the City of Wyandotte Michigan as follows:

1. The City Council by at least a three-fifths vote of its members elect, pursuant to the authority granted by Act Number 279 of the Public Acts of 1909, as amended, proposes that Chapter IV, Section 1, Section 2 and Section 5, of the Charter of the City of Wyandotte, be amended, to read as follows:

Provisions of existing Chapter IV, Section 1, of the Wyandotte City Charter, if approved by the electors, will be amended to read as follows:

Designated.

Section 1. The elective officers of the city shall be a mayor, six (6) councilmen, a city clerk, and a city treasurer, all of whom shall be elected at large, and shall be electors of the city.

Provisions of existing Chapter IV, Section 1, of the Wyandotte City Charter, to be amended by such proposal, if adopted, now reads as follows:

Designated.

Section 1. The elective officers of the city shall be a mayor, six (6) councilmen, a city clerk, and a city treasurer, a city assessor, all of whom shall be elected at large, and shall be electors of the city.

- 2. The purpose of the proposed Amendment is to eliminate the City Assessor as an elected officer and to make it an appointive officer.
 - 3. The proposed Amendment shall be submitted to the electors in the following form, to-wit:

Proposal 1 – Amendment to City Charter

Shall the Wyandotte City Charter be amended to provide, effective May 2021 for the City Assessor to no longer be an elected position and instead be appointed by the Mayor, subject to confirmation of the City Council; with changes for the purpose to Sections 1, 2 and 5 of Chapter IV, to Section 8 of Chapter VII, and to Section 20 of Chapter V, including the renumbering and transfer of Section 20 of Chapter V to Section 8.1 of Chapter VII?

4. If the proposed Amendment is adopted, then the following Sections of the Charter will be amended to read as follows:

CHAPTER IV. ELECTIVE OFFICERS

Designated.

Section 1. The elective officers of the city shall be a mayor, six (6) councilmen, a city clerk, and a city treasurer, all of whom shall be elected at large, and shall be electors of the city.

Terms and lengths of office.

Section 2. Commencing with the May 3, 2005 general election and on the first Monday in April of every fourth year thereafter, the mayor, the six (6) councilpersons, the city clerk, and the city treasurer, shall be elected for a term of four (4) years. Commencing with the April, 1997 general election, the mayor and any councilpersons shall be prohibited from seeking more than three (3) consecutive four (4) year terms of office for the same office, but this prohibition shall not apply to the city clerk or the city treasurer. The terms of all elective officers shall commence at 12:00 noon, Eastern Standard Time, on the first Monday following the election.

Compensation of elected officers.

Section 5. The elective officers of the city shall be entitled to receive as full compensation for their services the following annual salaries:

The mayor shall receive the sum of five thousand dollars (\$5,000.00). Each councilman shall receive the sum of two thousand five hundred

dollars (\$2,500.00).

The city clerk and the city treasurer shall receive such compensation as the council shall by ordinance determine.

ARTICLE V. DUTIES OF ELECTIVE OFFICERS

Section 20 of Chapter V of the Charter describes the City Assessor's duties and now read as follows:

The City Assessor shall perform such duties as are prescribed in Section 8 of Chapter VII of this charter and required of him by general law.

Section 20 of Chapter V of the Charter will be deleted from Article V and inserted in Article VII as Section 8.1 as follows:

ARTICLE VII. ADMINISTRATIVE DEPARTMENTS-APPOINTIVE OFFICERS

The following Section 20 of Chapter V of the City Charter which would be renumbered and placed in Article VII as follows:

City Assessor.

(Former Section 20) Section 8.1, Commencing May 2021, the City Assessor shall be appointed by the mayor, subject to confirmation by the council for a term of two years. Thereafter on the third Monday of May, and every second year thereafter, the City Assessor shall be appointed for a term of two (2) years. The City Assessor shall receive such compensation as the Council shall determine.

6. Section 8 of Chapter VII of the Charter describes the City Assessor as an elective position and now reads as follows:

The department of valuation and assessment shall be in charge of the city assessor who shall be an elective officer of the city and who shall be elected as in this charter provided. The city assessor shall perform such duties in relation to assessing property and levying taxes in the city as are prescribed by this charter. He is hereby authorized and required to perform the same duties that supervisors of townships under the general laws of the state are required to perform in relation to assessing the property and levying taxes for state, county and school purposes. He shall perform such other duties as are prescribed by law of assessors in cities, or are now or hereafter may be prescribed by ordinance or resolution of the council and shall make such reports as required by council.

Section 8 of Chapter VII of the Charter will be amended to identify the assessor's office subject to appointment as follows:

Department of valuation and assessment.

Section 8. The department of valuation and assessment shall be in charge of the City Assessor who shall be an appointive officer of the city and who shall be appointed as in this charter provided. The City Assessor shall perform such duties in relation to assessing property and levying taxes in the city as are prescribed by this charter. He is hereby authorized and required to perform the same duties that supervisors of townships under the general laws of the state are required to perform in relation to assessing the property and levying taxes for state, county and school purposes. He shall perform such other duties as are prescribed by law of assessors in cities, or are now or hereafter may be prescribed by ordinance or resolution of the council and shall make such reports as are required by the council.

- 7. The City Clerk shall forthwith transmit a copy of the proposed Amendment to the Governor of the State of Michigan for his approval, and transmit a copy of the foregoing statement of purpose of such proposed Amendment to the Attorney General of the State of Michigan for his approval, as required by law.
- 8. The proposed Charter Amendment shall be, and the same is hereby ordered to be submitted to the qualified electors of this City at a special election in the City of Wyandotte Election to be held on the 7th day of August, 2018, and the City Clerk is hereby directed to give notice of the election in the manner prescribed by law and to do all things necessary to submit such Charter Amendment to the vote of the electors as required by law.
- 9. The City Clerk shall have the proposed Charter Amendment, in full, posted in a conspicuous place in each polling place at the City of Wyandotte election.

2018-181 POLLING LOCATION CHANGE – PRECINCT 6

BE IT RESOLVED that the Council concurs with the request from the City Clerk to establish a permanent polling location for Precinct 6 at the P.L.A.V. Post #74 Hall, 963 Oak St.

BE IT FURTHER RESOLVED that the Council approves the notification of said change via a new Voter Identification Card printed and mailed by the services of Printing Systems, Inc. in the amount of \$550 to be paid from account number #101-840-750-220 (Operating Expenses, Election Commission). BACKGROUND: An individual recently asked the Clerk's office what the rules were for painting house numbers on the curb in front of residents' homes. While this practice has been carried out in the past, no set of rules for the application of house numbers to curbs could be located. After an exchange of ideas between the City Engineer, City Attorney, Police Department and the office of the Clerk, the attached criteria were deemed acceptable for the application of house numbers to curbs.

GUIDELINES FOR PAINTING HOUSE NUMBERS ON CURBS

- 1. Only house numbers painted on the face of curbs are permitted. No logos, designs, graphics or symbols of national, military, religious, sports, flags, college/university are permitted. Such logos, designs, graphics, and symbols may be registered trademarks and may have copyrights.
- 2. Only street numbers are to be painted on the curb. Full addresses are not permitted. Street numbers are not to exceed a height of six inches, and shall be either black on a white background, or white on a black background.
- 3. The painted curb number is not a replacement for the address that must be permanently affixed to the house.
- 4. The person(s) performing the painting shall notify the property owner whether the curb painting service being solicited is for payment or "charitable donation." Charitable donations are not mandatory contributions.
- 5. The person(s) must first obtain permission of the property owner before painting any house number on the curb. If the work is performed before obtaining the property owner's permission, the property owner is not obligated to provide payment for the curb painting services.
- 6. The person(s) shall wear high visibility clothing, such as a vest or jacket while occupying the road space from curb to curb.
- 7. Curb number painting shall only be performed between the hours of 8:00 a.m. and 5:00 p.m. Monday through Saturday. No painting shall be performed on Sundays.
- 8. The person(s) performing the numbering shall have in their possession the permit issued by the city and valid identification at all times.
- 9. Any complaints from property owners may result in the revocation of this permit.
- 10. Any person who fails to comply with these guidelines is in violation of Section 32-2 and Section 25-60 of the City of Wyandotte Code of Ordinances.

BACKGROUND: The City has had a Service Agreement with the County of Wayne since 1962 which specifies the duties and responsibilities of each party relative to conveyance and treatment of wastewater. This agreement expired in 2012. Since that time, the thirteen (13) communities that comprise the Downriver Sewage Disposal System (DSDS) have formed the Downriver Utility Wastewater Authority (DUWA) to negotiate a successor agreement with the County. Through these negotiations, a DTA has been agreed upon that includes DUWA acquiring the DSDS from the County of Wayne and becoming the owner of the system. It is envisioned that DUWA would hire a private operator for the system and the savings achieved would cover the purchase price of the transaction.

After months of due diligence, the DUWA Board has recommended the approval of the DTA.

Dear Mayor Peterson:

I write on behalf of the DUWA Board to advise you that it has recommended and advances to your community a Definitive Transfer Agreement (DTA) for the purchase of the Downriver Sewage Disposal System (DSDS or System) including the Wyandotte wastewater treatment plant from Wayne County. Your community is a constituent municipality of DUWA and has been aware this transaction has been in negotiation for the last two years. Attached is a copy of the DTA and an electronic copy has been sent to your municipal attorney.

On Thursday February 8, 2018 the DUWA Board unanimously approved the following motion:

First the DUWA Board recommends and advances for consideration the Definitive Transfer Agreement (Agreement) between DUWA and Wayne County for the transfer of the Downriver Sewage Disposal System (system) to its Community Members.

Second to have each Community take up for consideration the Agreement, to be circulated by DUWA's counsel with a model resolution, no later than April 30, 2018 and report back to the DUWA counsel each Community's decision in favor of the Agreement, against the Agreement or failure to reach a decision.

And finally, to advise each Community if the Agreement is supported by at least 66% weighted voting of the DUWA members and the Wayne County Board of Commissioners approves the Agreement it shall become effective on its terms.

Prior to that vote the Legal Committee of DUWA, which included your municipal attorney, concluded there were no substantive comments or changes to the DTA.

Your community is asked to vote on the DTA no later than April 30, 2018. We ask that your community authorize your DUWA representative to vote for or against the DTA at DUWA's May 10, 2018 meeting.

We anticipate that council members and trustees will need information about the DTA in order to proceed to a vote in April. An informational meeting was held on February 2 at the Southgate Veterans Memorial Library and the PowerPoint presentation from that meeting has been posted on the Authority website www.duwauthority.org for your review and use.

The Board has directed its advisors to make themselves available to your community during March 2018 to aid in the educational process. If your community would like a work session on the DTA, please contact the System Manager to set a date and time by emailing Lambrina.Tercala@OHM-Advisors.com. If multiple communities want to schedule a joint workshop, that would be encouraged to get the same information out to everyone.

We are arranging a site visit of the Wyandotte plant for mid-March so that council members or trustees could be given tour of the plant to better understand its operations and the assets being purchased. Ms. Tercala of OHM will be circulating an invite and signup sheet for the plant tour by email at least two weeks before the tour.

You will also find attached a model resolution that your community can use in this matter. A Word version can be sent to your office by contacting <u>ifausone@fb-firm.com</u>.

Once again, we ask your community to study this matter in March and take it up for a vote in April. Please contact me if there is any information that you need for this process.

Also PNC Bank submitted a communication dated February 7, 2018, indicating they do not have possession of the subject property and their name was not in the chain of title on the property.

Mr. Kowalewski indicated that communications were sent to the Baker's at the address of 951 3rd Street and 18121 Pinewest, Brownstown (last known address from the utility billing) and both letters were returned.

Taxes have not been paid since 2016 and the tax bills have been returned to the City.

Mr. Parker indicated that the property has not been repaired as directed at the past hearing. Mr. Parker continued that there are boarded-up windows, soffit missing and no permits have been secured to repair the property from the fire damage.

A check of the utility records indicated that the utilities have been off since September 2014.

Therefore, Mr. Parker indicated he would grant an additional thirty (30) days to complete the exterior repairs or demolish the home. If the violations indicated on the letter dated July 13, 2017, are not completed within the thirty (30) days of this hearing, then this matter will be referred to the Wyandotte City Council to be demolished.

Mr. Parker stated that the utilities had been cut in December 2015.

Ms. Roberts questioned under the Fire Escrow Act, if the escrow money could be used to demolish the property and make it safe.

Ms. Roberts continued that her information shows the property was insured by P & C Mortgage (and also registered) but that does not show up on the title work.

Mr. Parker stated that there is a sign posted on the building, Signal 1-800-533-9898.

Mr. Kowalewski suggested that Minnesota Title be contacted to check on the liber and page number for no mortgages being listed on the property, and the City would need their findings in writing. Mr. Kowalewski continued that there are two separate issues on this property, property maintenance with the fire, and the City does not know who to legally notify. Mr. Kowalewski stated that once the legal owner is found, they need to be notified about the fire and property maintenance violations, and recommended that this hearing be held in abeyance for 30 days to see what is going on with the title.

Ms. Roberts stated that she will contact Signal and Minnesota Title.







The City of Wyandotte Department of Engineering and Building has received a complaint regarding the condition of your building. A field inspection verified that your building is in violation of the Wyandotte Property Maintenance Ordinance. See the violations below:

#### AREA: Exterior

- Siding requires repair PM304.2/304.6
- Gutters / conductors require repair/replace /paint/downspouts disconnected PM304.2/508.1/MDEQNPDES
- Windows require repair PM304.14/304.15 INSPECTOR COMMENTS: Boarded up windows are prohibited.
- · Requires prevention of weeds PM303.4
- Rear porch requires guardrail and stairs permit required PM304.10/304.11

Further, a check of the records at the Wyandotte Department of Municipal Services indicates that the electric and water utilities were terminated in December 2015. The structure appears to have been vacant for over six (6) months.

Due to the lack of maintenance of the property at 915 – 3rd as noted by the attached violations, and the lack of occupancy, the undersigned deems the structures to be unsafe and dangerous.

Please be advised of the following from the City of Wyandotte Property Maintenance Code:

## Section PM-110 Demolition:

<u>PM-110.1 General</u>: The code official shall order the owner of any premises upon which is located any structure, which in the code official's judgment is so old, dilapidated or has become so out of repair as to be dangerous, unsafe, unsanitary or otherwise unfit for human habitation or occupancy, and such that it is unreasonable to repair the structure, to raze and remove such structure; or if such structure is capable of being made safe by repairs, to repair and make safe and sanitary or to raze and remove at the owner's option; or where there has been a cessation of normal construction of any structure for a period of more than two years, to raze and remove such structure.

## Section PM-202.0 General Definitions:

Dangerous Buildings: A building or structure that has 1 or more of the following defects or is in 1 or more of the following conditions:

- A. The building or structure is damaged by fire, wind, or flood, or is dilapidated or deteriorated and becomes an attractive nuisance to children who might play in the building or structure to their danger, or becomes a harbor for vagrants, criminals, or immoral persons, or enables persons to resort to the building or structure for committing a nuisance or an unlawful or immoral act.
- B. A building or structure remains unoccupied for a period of 180 consecutive days or longer, and is not listed as being available for sale, lease, or rent with a real estate broker licensed under Article 25 of the occupational code, Act. No. 299 of the Public Acts of 1980, being sections 339.2501 to 339.2515 of the Michigan Compiled Laws. For purposes of this subdivision, "building or structure" includes, but is not limited to, a commercial building or structure. This subdivision does not apply to either of the following:
  - (i) A building or structure as to which the owner or agent does both of the following:
    - (a) Notifies a local law enforcement agency in whose jurisdiction the building or structure is located that the building oar structure will remain unoccupied for a period of 180 consecutive days. The notice shall be given to the local law enforcement agency by the owner or agent not more than 30 days after the building or structure becomes unoccupied.
    - (b) Maintains the exterior of the building or structure and adjoining grounds in accordance with the BOCA National Property Maintenance Code 1990 and amendments adopted by the City of Wyandotte.
  - (ii) A secondary dwelling of the owner that is regularly unoccupied for a period of 180 days or longer each year, if the owner notifies a local law enforcement agency in whose jurisdiction the dwelling is located that the dwelling will remain unoccupied for a period of 180 consecutive days or mor3e each year. An owner who has given the notice prescribed by this sub paragraph shall notify the law enforcement agency not more than 30 days after the dwelling no longer qualifies for this exception. As used in this sub paragraph "secondary dwelling" means a dwelling such as a vacation home, hunting cabin, or summer home, that is occupied by the owner or a member of the owner's family during part of a year.

You are hereby directed to correct the noted violations, maintain the exterior of the property, occupy and/or list the structure with a real estate broker in accordance with Section <u>PM-202.0</u> referenced above. Should you elect to rent or sell this property, an Upon Sale or Rental Inspection is required according to the City of Wyandotte Code of Ordinances Sec. 19-5 and 31.1-11. The inspection and fee can be arranged and paid for at City Hall in the Department of Engineering and Building.

Failure to correct the cited violations, maintain and occupy the structure by August 17, 2017, will result in this Department proceeding with Section PM-107.3 Disregard of notice, of the Property Maintenance Code, at which time a hearing date will be set to determine whether or not the structures should be demolished, and tickets will be issued as per Section PM-106.0 Violations. You also have the right to seek modification or withdrawal of this notice by requesting a Show Cause Hearing.

Further, in accordance with the attached Article VII "Abandoned Residential Structure", of Chapter 7 "Building and Building Regulations" of the City of Wyandotte's Code of Ordinances, this dwelling is deemed to be an abandoned residential structure. Therefore you must register the property in accordance with Sec. 7-76.

Registration of the Ordinance. Failure to do so by July 31, 2017, you will be subjected to the violations and penalties as set forth in Sec. 7-83 of the Ordinance.

CITY OF WYANDOTTE, WAYNE COUNTY, MICHIGAN ORDAINS:

## Section 1. Purpose and Intent

It is determined necessary for the health, safety and welfare of the City to adopt this article regulating the location and operations of Outdoor Cafes Uses.

<u>Section 2.</u> Amendment to Section 2202 "Special Land Use Designated" by amending Paragraph S of Article XXII "Special Land Uses" of Zoning Ordinance shall read the follows:

Article XXII – Special Land Uses, 2202. Special Land Use Designated S – Outdoor Café

 Subject to all of the conditions described herein, an outdoor café may be set up and used annually from January 1 through December 31. The permitted hours of operation are:

Monday 7:00 a.m. to 12:00 Midnight (17 hours)

Tuesday 7:00 a.m. to 12:00 Midnight (17 hours)

Wednesday 7:00 a.m. to 12:00 Midnight (17 hours)

Thursday 7:00 a.m. to 12:00 Midnight (17 hours)

Friday 7:00 a.m. to 2:00 a.m. Saturday morning (19 hours)

Saturday 7:00 a.m. to 2:00 a.m. Sunday morning (19 hours)

Sunday 7:00 a.m. to 12:00 Midnight (17 hours)

In addition to the above:

Each day of the Wyandotte Street Art Fair 7:00 a.m. to 2:00 a.m. of the following day (19 hours)

March 17 (St. Patrick's Day) 7:00 a.m. to 2:00 a.m. of the next day (19 hours)

New Year's Eve 7:00 a.m. to 2:00 a.m. of the next day (19 hours)

Wednesday immediately before Thanksgiving Day 7:00 a.m. to 2:00 a.m. of the next day (19 hours)

Thursday immediately before Traditional Easter Sunday 7:00 a.m. to 2:00 a.m. of the next day (19 hours)

Noise radiating from an outdoor café, which exceeds 75 DBA between 7:00 a.m. to 12 midnight or 65 DBA for all other times shall constitute prima facie evidence that such noise unreasonably disturbs the comfort, quiet and repose of persons in the area and is prohibited. The "DBA" represents the sound pressure level in decibel measured on the "A" scale of a standard sound level meter. Noise level measurements shall be taken at the zoning district boundary of any residential zoning district, recreation unit district and any planned development as may be

appropriate. In all other districts, noise level measurements shall be taken at the property line of an affected property. No one will be allowed to have possession of food or drink on the Café except during the permitted hours as set forth in this section.

Upon request, the City Council may by resolution, extend the dates of operations or the hours of operation. A public hearing on said request shall first be held by the Planning Commission (under the same procedures for approval of special land use). Upon receipt by the City Council of recommendation of the planning commission the City Council may approve the request.

The criteria for approval will include the impact on adjacent or nearby residential, religious, educational or commercial properties and review of previous or current compliance with all city ordinances, state and federal regulations.

Any approval for extension of dates or hours shall be issued on a calendar year basis and shall expire on December 31<sup>st</sup> and must be renewed annually. The City Council may grant a renewal of the extended dates or hours without the necessity of a public hearing if it determines the applicant is in compliance with all requirements of all city ordinances and approvals for the special land use. Any approval for extension of dates or hours is subject to revocation by the Planning Commission in accordance with paragraph H, section 2201.

- 2. A site drawing showing the detailed plan of the outdoor café must be submitted to and approved by the Planning Commission. The detailed plan is to include: the design, relevant details and location of all temporary structures such as awnings, planters, landscaping, railing, tables, chairs and other equipment, as well as lighting and electrical outlet locations. The location of entrances and exits shall be shown. For cafes on public property, the plan shall also show existing sidewalks, buildings, curbs, existing improvements, i.e., lamp posts, street trees, benches, mailboxes, etc., and an unobstructed clear area for pedestrian use (a minimum of 60"). A minimum clearance of seven (7) feet shall be maintained between the sidewalk and bottom edge of table umbrellas or awnings. The layout shall show all seating, tables and chairs and shall be used to determine maximum occupancy load for the outdoor café. The occupancy load shall be posted in a conspicuous location.
- 3. Plans for setting up the outdoor café must be approved by the Department of Engineering and Building to provide for the free passage of pedestrians along the sidewalks, by the Police Department to provide for traffic and pedestrian safety, and by the Fire Department for fire-safety issues. An outdoor café which is adjacent to residential properties or shares an alley with residential properties shall be screened with a solid fence a minimum of six (6) feet high.
- 4. The outdoor café must be part of a licensed restaurant and meet all the requirements of the department of health and any other local, county or state requirements, including the City of Wyandotte's ordinance and the Michigan Liquor Control Commission (if applicable).
- 5. For outdoor cafes on public property, liability insurance, Liquor Liability Coverage and property damage coverage naming the City of Wyandotte as an insured party, in an amount approved by the City of Wyandotte's City Administrator, must be provided before an outdoor café may be set up and be maintained for as long as the outdoor café is in operation.
- 6. Approval of the City Council is required for the proposed use of any public area or facility. All provisions of a Grant of License must be complied with at all times. Consideration for approval for use of any public area shall be limited to public property that is situated within fifty (50) feet of the extended property boundaries of property owned by the applicant. Any public outdoor café not within the road right-of-way may also require a written lease as determined by the City Council.

- 7. An outdoor café in a B-2 district may provide for only thirty five percent (35%) more seating than is provided inside the restaurant. Additional parking shall be provided for the square foot area of the outdoor café in accordance with Section 2403.
- 8. No sign or any other form of advertising is permitted in the dining area, nor on fences or railings of such area with the exception of an identification or menu sign. The name of the establishment may appear on the valance of an umbrella. No display of merchandise for sale shall be allowed.
- 9. Furnishings of an outdoor café shall consist solely of readily removable awnings, covers, canopies, railings, tables, chairs, planters containing plants and accessories. Furnishings may not be attached, even in a temporary manner, to the sidewalk or other public property, except that canopies and railings, shall be secured by means of flush mounted anchors or other methods approved by the Building Official. No objects which are part of an outdoor café, except lighting fixtures, railings, awnings, or other nonpermanent covers or canopies, may be attached, even in a temporary manner, to any building, or structure on which the outdoor café abuts. When the associated establishment and/or the outdoor café on public property are not open for daily use, all furnishings and fixtures, unless otherwise specifically approved, shall be removed from the public property or stored in an approved manner which shall not cause a public nuisance or hazard. The Building Official shall determine when fences on public property shall be removed. The Building Official shall determine when a hazardous condition exists in the public right-of-way and on other public property. Any fence abutting public right-of-way or in public right-of-way must be of black metal material. Shop drawings plans shall be provided with each application for fencing and all furniture on any outdoor café for review by the Planning Commission.
- 10. Outdoor dining areas must remain clear of litter, food scraps and soiled dishes at all times. All Outdoor Café shall post the hours of operations as specified by the City Engineer.
- 11. Annual inspection of the outdoor café to be conducted by the Engineering and Building Department for compliance with approved plan. All outdoor cafes shall apply annually to the Engineering and Building Department for approval and no person may operate an Outdoor Café until such annual approval by City is granted for the given year. A public hearing will be required for an existing outdoor café only if a written complaint, changes to Outdoor Café layout or violations are received by any City Department in the previous year. The Engineering and Building Department will be responsible to receive written complaints concerning an outdoor café and said complaints shall be forwarded to the Planning Commission. The City Council will approve an application checklist which will include yearly fees for application review, inspections, use of public area and review of insurance. This checklist will be utilized for inspection by the Engineering and Building Department. The yearly fee will be established by City Council Resolution.

## Section 3. Reservation of Rights.

Nothing in this Ordinance or in the Code hereby adopted shall be construed to affect any suit or proceeding in any court, or any rights acquired, or liability incurred, or any cause or causes of action acquired or existing, under any act or ordinance hereby repealed; nor shall any just or legal right or remedy or any character be lost, impaired or affected by this Ordinance.

Severability. Should any word, sentence, phrase or any portion of this Ordinance be held in a manner invalid by any court of competent jurisdiction or by any state agency having authority to do so for any reason whatsoever, such holdings shall be construed and limited to such word, sentence, phrase or any portion of the Ordinance held to be so invalid and shall not be construed as affecting the validity of any of the remaining words, sentences, phrases or portions of this Ordinance.

## Section 5. Conflicting Ordinances.

Conflicting Ordinances. All prior existing ordinances adopted by the City of Wyandotte inconsistent or in conflict with the provisions of this Ordinance are, to the extent of such conflict or inconsistency, hereby expressly repealed.

## Section 6. Effective

This Ordinance shall take effect along with the notice of adoption in a newspaper generally circulated in the City of Wyandotte within ten (10) days after adoption and shall take effect fifteen (15) days from the date after adoption or seven (7) days after publication, whichever is later. The notice of adoption shall include the text of the amendment, the effective date of the Ordinance and the place and time where a copy of the Ordinance may be purchased and inspected.

Commissioner Benson asked if there would be 3 apartments on the ground level and 4 apartments on the  $2^{nd}$  floor.

Mr. Roberts indicated that was correct. Mr. Roberts continued that these are just preliminary plans and he would bring the final floor plans for the next review.

Commissioner Benson asked what the size of the units would be.

Mr. Roberts indicated that they would be one (1) bedroom 600 square feet each. Mr. Roberts indicated that the building is in good shape and this development would be really nice.

Mr. Tallerico reviewed the process of the PD District and indicated that the Commission's recommendation would be sent to the City Council and the Owner/Applicant would come back to the Commission with final plans.

Commissioner Benson asked about the parking.

Mr. Roberts indicated that they would have 11 spaces and only 9 spaces are required.

The Commission and Mr. Roberts reviewed the plans submitted.

Betty Dunn, her mother Ms. Brooks owns the property at 728 Grove. Ms. Dunn is concerned about the use of the alley and if it would be used to enter the parking lot. Ms. Dunn is

expressed further concerned about the fence at the rear. Ms. Dunn stated that the Church never had enough parking and she is concerned about their property being used.

Mr. Roberts indicated that they would be replacing the fence with a steel picket fence and the alley would not be used for parking.

Mr. Roberts reviewed the plans with Mrs. Dunn and her mother.

Chairperson Pasko asked if there was anyone else present who wished to speak regarding this hearing. There being none the hearing was closed.

**PUBLIC HEARING** to hear comments regarding changes to Article XXII Special Land Uses Sub-Section 2202 Special Land Uses Designated amending Section S. Outdoor Café, Sections 1 -11

Corki Benson, 404 Vinewood, Wyandotte indicated that she is representing Garfield United and the Wyandotte Community Alliance. Ms. Benson read her communication which is attached.

Bruce Yinger, 117 Chestnut, Wyandotte. Mr. Yinger indicated that he can't understand why the ordinance is being changed again when the current ordinance is not being enforced. Mr. Yinger indicated that he does not have any issues with the building, at 126 Oak but the building was designed for 300 plus people. Mr. Yinger further indicated that he understands that he lives by an entertainment district, but the operations should stay within the building.

Mr. Yinger continued that the people going to the cafes are disrespectful and the stipulations that are currently on the property are not being enforced and there should be no changes made to the ordinance at this time.

Joseph Hirsch, 144 Chestnut, Wyandotte. Mr. Hirsch indicated that extending the hours until 2:00 a.m. is a bad idea and asked how that improves the quality of life. Mr. Hirsch continued that the noise goes on well past midnight and it is unbearable.

Mr. Hirsch indicated that there are people out on the café at Captain's past midnight smoking and there is no one in the building. Mr. Hirsch stated that Captain's is a repeated violator of the Ordinance and state law. Mr. Hirsch submitted a list of events that he witnessed of issues at Captain's.

John Howey, owner of 114 Oak Street representing the tenants of the Edinger Apartments. Mr. Howey indicated that his family has owned the building for 50 years and the tenants have issues with people smoking and the smoking going into their apartments and it is not fair for them to live with second hand smoke. Mr. Howey indicated that he feels they are in violation of the Smoke Free Law in Michigan.

Mr. Howey stated that the tenants are also dealing with noise from the use of the café and the café is used well past midnight and any changes to the ordinance should be denied.

Mary Guilloz, 145 Chestnut. Ms. Guilloz indicated that she does not understand why the Ordinance is being reviewed because a 23 year old girl was not happy and submitted a petition. Ms. Guilloz indicated that she and her husband have lived in Wyandotte their whole lives and she does not feel it should be changed.

Ms. Guilloz stated that they are complaining about the outdoor café emptying at midnight what would happen at 1:00 a.m. or 2:00 a.m. it would be worse.

Ms. Guilloz asked the Commission to look at the residents as a priority over 1:00 am and keep everything as it is instead of looking at petitions signed by people who don't even live in the area or Wyandotte.

Dan Helka, 116 Oak. Mr. Helka stated that he understands the noise problems and his resolution would be no music outside. Mr. Helka further indicated that when they ask customers to leave the outdoor café at midnight the people are not happy that they have to leave. Mr. Helka continued that during the week there are no problems, but on the weekend there are only so many people they can hold in the inside and the customers just don't understand why they have to leave,

Mr. Helka indicated that he would like to see the following changes:

Fees are a bit excessive and they should be lowered.

Insurance requirements are in excess and above what the state requires.

Dates should be extended and even be all year round.

Owner of RP McMurphy's was present and indicated that he feels the dates of the outdoor café should be all year and he is in favor of extending the hours. RP McMurphy's further indicated that the fees need to be lowered; he already pays for a business license and does not understand why it is so much for the outdoor café license.

Bob Salamon, Commander of the American Legion Post in Bishop Park. Mr. Salamon indicated that he feels the fees are too high and there should be a difference fee for bars since they are a business with customers and clubs since they have members and they are not open to the public.

Mr. Salamon asked what the difference was between the \$150 fee and the \$600 fee.

Chairperson Pasko indicated that the fees are established by the City Council and the Commission discussed this last year and it was determined that if you had a liquor license, the fee would be \$600,

Les Salliotte, 2827 2<sup>nd</sup> Street, Wyandotte. Mr. Salliotte indicated that he would like to see all patios stay open until 2:00 a.m. all year around. Mr. Salliotte indicated that they remove their own snow so it would not be an issue.

Mr. Salliotte indicated that at one time the Planning Commission wanted the cafes opened until 2:00 a.m., but it did not get approved by Council.

Mr. Salliotte indicated that there has been a lot of talk about music and they have a decidable read and they use it quite often to make sure they are in compliance and they are usually at 55 decibels when they take it at the property line. Mr. Salliotte indicated that Captain's has never received a ticket for noise violation.

Mr. Salliotte indicated that he feels that the Liquor Control Commission rules should apply to the outdoor café which would allow it to stay open until 2:00 a.m.

Mr. Salliotte submitted a letter from the City Attorney regarding the use of the outdoor café to be allowed for smoking attached.

Commissioner Sarnacki stated that a couple of months ago the Commission reviewed Captain's rear café and adopted a Resolution that the rear café could not be used as a no smoking area and he is not sure what the issue is.

The Commission had a conversation with the Rick DeSana and Les Salliotte, Owners of Captain's regarding the State of Michigan Smoking Laws.

The Commission indicated that maybe a legal opinion needs to be received from the City Attorney regarding smoking laws.

Mr. Salliotte asked if the Commission received the picture showing patrons in the street and on the sidewalk when the outdoor café closes. Mr. Salliotte further indicated that the outdoor café should be allowed to stay open so their customers would not have to go into the sidewalk or street area to smoke.

Mike Mazloum, owner of 130 Maple, Wyandotte. Mr. Mazloum indicated that he supports the other bar owners and feels that the outdoor cafes should be allowed to be open all year if the weather permits and they should be able to be open until 2:00 a.m. Mr. Mazloum indicated that it is very hard on the restaurants and bars in the winter to bring people in to their businesses.

Mary Guilloz, 145 Chestnut. Ms. Guilloz indicated that the residents on her block have put a lot of money into their properties and she would hate to see these good residents move out of Wyandotte because of outdoor cafes. Ms. Guilloz further stated that she feels that the Ordinance should stay the same.

Chairperson Pasko asked if there was anyone else who wished to speak regarding this hearing. There be none the hearing was closed.

In the last two (2) years, the earliest work day was December 7 and the latest work day was March 14. The owners will need to have furniture and fencing removed in order for the DPS to complete the removal.

I have no objections to any proposed change in dates of set up and use for outdoor cafes as long as the DPS can perform their duties. If changes are being considered perhaps different time frames should be provided for public areas and private property.

I believe it is time for a little history lesson in regards to the issues regarding outdoor cafes. Many of you will remember and some of you are too young to understand that history repeats itself....even in Wyandotte.

Once upon a time the south end of Wyandotte was a residential area of old homes surrounded by numerous bars. Those bars and the activity they created eventually turned many of those residential homes into flop houses. The one sure thing that was in that neighborhood every night was the police paddy wagon and not just from 2-3AM but on some days on/and/off/ all day! Mayor DeSana and urban renewal took over and eventually with the help of people like Jim Johnston and the McKinley Neighbors United things changed. There is now an entire area of Wyandotte populated with residents, a couple bars, and new homes that replaced those flop houses and that busy paddy wagon.

Another time a bar on the river created a situation where the surrounding residential neighborhood was the victim of last call. It included bottles and can trash, parking problems, patrons peeing in the street, and loud noises and fights on their front lawns every weekend. Residents complained constantly. The city put up signs to try and solve the parking problems on the street forcing many patrons to park and walk as far away as Copeland Center. Police officers began working the area and many city council members and Garfield Neighbors United members walked the streets when the bar closed at 2AM. The bar eventually closed for whatever reason and the neighborhood problems stopped.

We all know things change. New ideas brought outdoor cafes to Wyandotte.


The old law of drinking on public streets created a need for an ordiance to provide rules and regulations equal for all these outdoor cafes.

Some of these outdoor cafes are in areas surrounded by neighbors who live in a 9 to 5 world and are now influenced by the outdoor cafes and their night time activities. Residents now hear "new noises" coming from these cafes when they

are ready to go to sleep. Outdoor cafe owners argue that people who bought their houses in Wyandotte should have known that bar could open near their house. But a bar is different from the new outdoor cafés. Bar activities are usually confined to the inside of the bar not in the public outdoor areas of a chosen neighborhood. Hence the hours of operation are dictated by the ordinace.

In the past and during the growth of these 30+ outdoor cafes there have been issues of the midnight closings not being enforced in some cases under the current ordiance. Now comes the history lesson part again.....if outdoor cafes are allowed to be open until 2AM when even the midnight closings cannot consistantly be enforced, the residents will be exposed to much later closing activities due to extra traffic noises, extra people-sometimes not sober- in their neighborhood and music and smoking which have been some of the current complaints.

Open cafes are big business but so are neighborhoods. It would be very sad if the issues with outdoor cafes are not resolved in a manner acceptable to <u>all of Wyandotte</u>, because history may just have an opportunity to repeat itself again.



Extending café hours to one o'clock in the morning is a bad idea.

How does that in any way improve the quality of life in Wyandotte?

As a resident living on Chestnut Street I can tell you the noise coming from Captain's Bar on every warm night is very disturbing. It usually goes on well past midnight in violation of the café ordinance. If allowed to continue and with increased occupancy it'll be unbearable. It has already affected the health and welfare of the neighbors.

Perhaps you can't picture just what it's like. So imagine a neighbor of your's has a party. Maybe a graduation party. Fifty or sixty people show up. It gets very loud and goes on late into the night/early morning. As a good neighbor you say well it's just one night or maybe you are even part of the festivities. But the next weekend it's the same on Friday, Saturday even Sunday night. And again on the third weekend. You can't stand it any longer. By then you're calling the police. They arrive to tell the partyers to shut it down or get a ticket. Then go to court facing a fine.

Captain's Bar does this every weekend, consistently violating the midnight cafe curfew. Although it's not a café really. It is a loud, wild, frat like, drinking party every warm weather weekend night and many week nights. There are nights when one would like to go to bed at a reasonable hour with windows open. But that's impossible in our neighborhood given the racket across the street. Our right to relative quiet has been stolen from us.

The owners claim it's permissible to allow the patio to be a smoking area. But it's not just a smoking area. Walk by the bar windows and you will see just a few patrons inside while there are 50 to 75 people out on the patio. Some smoking, all with drinks.

In light of the repeated violations Captain's should not have a café permit, let alone permission to expand the facility. The expansion puts them 50' from an existing residence. That's unacceptable!

The owners have told us on a few occasions that they want to be good neighbors.

That's a disingenuous statement considering their obvious lack of



consideration for the neighbors.

Courtesy has given way to profit and it equals greed. Is that what's really going on here!

I discussed the smoking issue with the Chief of Police and he has no problem with smoking after midnight outside of the Pub if it does not disturb the peace. If the outdoor cafe is being used for entertainment, music and/or service of guests, that would be in violation of the ordinance after 12:00 midnight.

With regards to the city zoning ordinance, a special land use has been approved for outdoor cafes subject to restrictions as set forth in the planning commission approval and the city ordinances.

The LCC indicates that the licensee shall comply with all zoning ordinances and therefore the restrictions in the zoning ordinance for <u>outdoor cafes</u> are applicable to your client's premises.

If you are aware of any legal authority to the contrary please submit it to my attention. MAC 436.2114 addresses a local government unit prohibiting the <u>sale</u> of alcohol during certain hours. The City Zoning Ordinance for outdoor cafe's pertains to <u>outdoor</u> service during certain hours due to noise and other matters.

Please be aware that you have approval to operate the outdoor café until midnight.

### Michigan Smoke Free Law Frequently Asked Questions General Information

Beginning May 1, 2010, smoking is prohibited in most public places in Michigan. The law will cover any workplace and any food service establishment. This law covers public places, including, but not limited to, restaurants, bars, shopping malls, bowling alleys, concert halls, arenas, museums, mechanic shops, health facilities, nursing homes, education facilities, and child care centers.

## Why was the law passed?

The Michigan legislature passed the Dr. Ron Davis Smoke-Free Air Law on December 10, 2009 to preserve and improve the health, comfort, and environment of the people of the state by limiting exposure to secondhand smoke. Governor Granholm signed the bill into law on December 18, 2009.

When does the law go into effect?

May 1, 2010

Will the local regulation/ordinance in my county/city/township still apply?

The Dr. Ron Davis Smoke Free Air Act will not serve as the only smoke free law in the state, but it does set forth the minimum requirements for indoor workplaces and public places where smoking is regulated and these minimum standards apply state-wide. The statewide law does the following: (1) establishes where people can smoke and where they can't if your local community is not currently covered by any city or county local law; and (2) ensures that any provisions that are weaker in your local law (compared to the state law) are now made AT LEAST AS STRONG as the statewide law.

## Where are people not allowed to smoke?

Under the new law, smoking is prohibited in public places and food service establishments. A public place means an (i) enclosed indoor area owned or operated by a state or local governmental agency and used by the general public; (ii) an enclosed indoor area used by the general public and is an educational facility, a home for the aged, nursing home, hospice, or hospital long-term care unit, auditorium, arena, theater, museum, concert hall, or any other facility during the period of its use for a performance or exhibit of the arts; (iii) unless otherwise exempted, a place of employment. Place of employment means an enclosed indoor area that contains one or more work area for one or more persons employed by a public or private employer.

How are multi-unit apartment buildings and condominium buildings affected by the smoke-free law?

#### Bars, Restaurants, and Other Food Service Establishments

#### What is a food service establishment?

A food service establishment is defined in section 1107(n) of the food law of 2000, 200 PA 92, MCL 289.1107 as: a fixed or mobile restaurant, a coffee shop, a cafeteria, short order café, luncheonette, grill, tearoom, sandwich shop, soda fountain, tavern, bar, cocktail lounge, nightclub, drive-in, industrial feeding establishment, private organization serving the public, rental hall, catering kitchen, delicatessen, theater, commissary, food concession, or similar place in which food or drink is prepared for direct consumption through service on the premises or elsewhere, and any other eating or drinking establishment or operation where food is served or provided for the public.

#### Where is smoking prohibited in a restaurant?

Smoking is not allowed in any indoor area as well as outdoor areas such as patios or rooftops where patrons are intended to receive service or consume food, beverages, or both.

### Where are restaurant guests or employees permitted to smoke?

Smoking may be allowed in outdoor areas where food, beverages, or both are not intended to be served or consumed.

## My establishment only has a liquor license, does the smoke free law still apply to me?

Yes, your establishment is still considered a food service establishment under the Food Law Act No. 92 of 2000 as amended.

## What do food service establishment operators need to do to comply with this law?

Food service establishment operators shall prohibit smoking in areas where it is not permitted. Compliance is determined by the following:

- Clearly and conspicuously post "no smoking" signs or the international "no smoking" symbol at each entrance and in other areas where smoking is prohibited under this act. These other areas may include outdoor areas such as patios or rooftops where patrons are intended to receive service or consume food, beverages, or both.
- Removing ashtrays and other smoking paraphernalia from anywhere where smoking is prohibited. "Smoking paraphernalia" means any equipment, apparatus, or furnishing that is used in or necessary for the activity of smoking.

- Use of the outdoor café shall be allowed from 7:00 a.m. to 12 midnight with extended hours to 2:00 a.m. on 3<sup>rd</sup> Fridays, Street Art Fair and events approved by Resolution by the City Council from March 15 through November 15.
- The outdoor café shall comply with all applicable laws and regulations of the City, County, and the State.
- 7. Umbrellas to have name of establishment on the drip-tee only, no logo's for products.
- 8. Occupancy is limited to 36 persons
- 9. Approval by the Wyandotte City Council for the use of City -Owned Property.

#### SPECIAL ORDER:

Commission discussed with Superintendent Lanagan:

Superintendent Lanagan stated the golf course opened on March 26, 2018. A suggestion was made of offering a discount for multiple golf memberships purchased for persons in the same household. Twelve memberships were sold in 2017 and currently ten memberships have been sold in early 2018. Rates have been set at \$400.00 for seniors age 55 & Older and \$550.00 for persons 54 & under. Memberships will not be allowed for use on outings, however it can be used to cover League Green fees. Vice President Ronco recommended a 50% discount and Superintendent Lanagan recommended 25%.
