John & Cindy Dainus, 1034 Orange, Wyandotte (owner & appellant)

for a variance **to obtain a building permit for a porch** (Lots 211 and 212, Assessor's Wyandotte Plat #11) in a RA zoning district, where the proposed conflicts with Section 2500.6 of the Wyandotte Zoning Ordinance.

#### **SECTION 2500.6:**

An unenclosed terrace porch may project into a front yard for a distance not exceeding six (6) feet and may include a fixed canopy or awning, but this shall not be interpreted to include enclosed sides. This porch projects into the front yard 10'-3 1/4".

Proposed front porch will not hinder or discourage any appropriate development or use of the adjacent land and buildings, or impair the value thereof.

A motion was made by Member Olsen supported by Member Gillon to grant this appeal.

Mrs. Dainus replied that they just intended to do a little, but it got bigger. Member Trupiano asked if there would be railings. Mr. Dainus replied yes.

Member Gillon asked if they built over the existing concrete porch. Mr. Dainus replied yes.

Mrs. Dainus commented that the porch has been checked by their daughter, and it is structurally sound.

Member Olsen commented that there are a couple of porches that protrude out further than this porch.

Mrs. Dainus added that she had spoken with several neighbors, and they had no objection.
