ITEM: Employee Compensation - One-time Payment

PRESENTER: Todd A. Drysdale, City Administrator Duydale

**INDIVIDUALS IN ATTENDANCE: N/A** 

BACKGROUND: Attached is an analysis that was prepared which outlines the cost of a one-time payment to all eligible full-time General City, Police, Fire, and Dispatch employees. This analysis separates the cost per collective bargaining unit and for the non-union employees. Note that, by law, elected officials are prohibited from getting an increase in compensation during their term of office. It is also assumed that employees hired during the year would only receive ½ of the recommended amount.

Also attached is an analysis that shows the historical compensation increases for City employees. In short, across-the-board raises have been extremely limited over the past ten (10) years and non-existent in the time periods since 2009 for non-union employees and 2012 for union employees. All collective bargaining agreements do not include a scheduled "across-the-board" raise until at least January of 2016 with two (2) collective bargaining units not scheduled for a raise until at least January of 2019.

The 2014FY budget expected a use of fund balance of approximately \$185k. Our preliminary 2014FY financial results show an excess of revenues over expenditures of approximately \$200k or a positive variance of \$385k. Thus, this payment can be made without affecting the beginning 2014FY fund balance amount of \$3.2 million or negatively affect the five (5) year projection presented to the City Council during the budget preparations.

It is recommended that this one-time payment be approved.

The MOA's will also specify that the payments will not be included in the Final Average Compensation (FAC)

used for defined benefit pension purposes nor will it be included in base wages for defined contribution (401a) matching purposes.

ITEM: Compliance with PA 152 of 2011, as amended

**INDIVIDUALS IN ATTENDANCE: N/A** 

BACKGROUND: In 2011, the State passed PA 152 otherwise known as the Publicly Funded Health Insurance Contribution Act (PFHIC), which was amended in PA 269-273 of 2013 and PA 184 of 2014. These laws were designed to lessen the burden of employee healthcare costs on public employers. There are four (4) options available to each public entity:

- 1. Apply the Hard Cap (capped dollar amount each government employer may pay towards an employee's healthcare costs;
- 2. Adopt by majority vote the 80%/20% cost-sharing-model;
- 3. Opt out of the cost-sharing model as set forth in the law;
- 4. Elect not to follow the statute (non-compliance).

For the first three years that this law has been in effect (2012, 2013, 2014), the City has adopted the 80%/20% cost sharing model. Using this option for compliance requires an annual resolution from the elected body.

It is recommended that this cost-sharing model continues to be approved due to the significant cost savings derived by the City.

ACTION REQUESTED: Adopt a resolution affirming the continued application of the 80%/20% Cost Sharing Option allowed under PA 152 of 2011

<u>BUDGET IMPLICATIONS & ACCOUNT NUMBER:</u> The application of the 80%/20% cost sharing of medical and prescription costs provides approximately \$400,000 in savings to the City. The amount is already included in the current and future year budgets.

BACKGROUND: The original Water Treatment Plant (WTP) filters were constructed with a conventional treatment process in the late 1940's and included single media gravity filters 1-6, In the 1970's the WTP was expanded with the addition of filters 11-16, which are dual media with surface wash equipment. Filters 7-10 which were constructed in the 1920's and are very similar design as filters 1-6, have been removed from service for many years and due to insurmountable design problems with these filters it was decided to remove them from the rehab project. While working with Process Engineering over the last three years with different types of operations we had considered replacing the existing filters with microfiltration units, air scouring units and nano filtration units. The price of each were very costly with the lowest being air souring filtration at 4.5 million to microfiltration units at 6.6 million and each required complete piping and building re-configurations before they could be installed. The current project will completely rebuild the filters from the ground up, which includes piping, valve replacement, instrumentation, cement repair, painting (epoxy to inside of the filter box), trough cleaning and replacement, media replacement, and repairing of the current filter bottoms.

Bid #4649 was posted 10/30/2014 on the Michigan MITN System with a close date of 11/14/2014. A single bid was received from Utility Service Group with the following results:

Utility Service Group's bid for the filter renovations included the offer to spread costs for deferral over a four year period beginning in the Fiscal 2015 and ending in Fiscal 2018.

Year 2015---\$723,000 Year 2016---\$819,000 Year 2017--\$819,000 Year 4: 2018 - \$819,000 Grand Total--\$3,180,000

STRATEGIC PLAN/GOALS: Improvement of Water Distribution facilities.

#### BACKGROUND:

Attached is the proposed Brownfield Plan (the "Plan") for Site No. 20, addressing the property commonly known as 3247 Biddle Avenue. The Plan complies with the Brownfield Redevelopment Financing Act, Act 381 of 1996, as amended. The Wyandotte Brownfield Redevelopment Authority (WBRDA) approved the Plan on August 19, 2014, subject to approval by the City Council (Attachment 3) and the Wyandotte Downtown Development Authority (DDA), and the DDA approved their support of the Plan and the transfer of tax increment capture on August 19, 2014 (Attachment 4), in accordance with the Interlocal Agreement approved by the DDA and WBRDA in March 2014.

To summarize, the Developer, GLPMR, LLC (Great Lakes Physical Medicine & Rehabilitation, P.C.), is requesting reimbursement for activities identified in the Brownfield Plan in an amount not to exceed \$500,000, with approximately \$293,000 captured from tax mileages the DDA would otherwise capture, and the remaining amount of approximately \$206,000 captured from tax millages the DDA wouldn't capture (for example, the Local School Operating (LSO) and State Education Tax (SET) millages). The WBRDA will reimburse the Developer through the annual increment captured under the Brownfield Plan when the property is redeveloped. Further approval of the Brownfield Plan and the associated Work Plan is required by the Michigan Strategic Fund (MSF) and the Michigan Economic Development Corporation (MEDC) in order to capture the LSO and SET millages. A one-page summary of the Plan is provided on page 2 of the Plan.

To the extent allowed by law, it will fulfill all permit requirements and will save harmless, represent and defend the County of Wayne and all of its officers, agents and employees:

from any and all claims and losses occurring or resulting to any and all persons, firms, or corporations furnishing or supplying work, services, materials, or supplies to the Community as the result of the Community's installation, construction, operation, repair or maintenance activities which are being performed under the terms of the Permit on, over, and/or under the County right-of-way or any local road; and

from any and all claims of every kind for injuries to, or death of, any and all persons, and for loss of or damage to property, and environmental damage or degradation, and from attorney's fees and related costs arising out of, under, or by reason of the Community's installation, construction, operation, repair or maintenance activities which are being performed under the terms of the Permit on, over, and/or under the County right-of-way or any local road, except claims resulting from the direct negligence or willful acts or omissions of said County performing permit activities.

Any work performed for the Community by a contractor or subcontractor will be solely as a contractor for the Community and not as a contractor or agent of the County. Any claims by any contractor or subcontractor will be the sole responsibility of the Community. The County shall not be subject to any obligations or liabilities by vendors and contractors of the Community, or their subcontractors or any other person not a party to the Permit without its specific prior written consent and notwithstanding the issuance of the Permit.

The Community shall take no unlawful action or conduct, which arises either directly or indirectly out of its obligations, responsibilities, and duties under the Permit which results in claims being asserted against or judgment being imposed against the County, and all officers, agents and employees thereof pursuant to a maintenance contract. In the event that same occurs, for the purposes of the Permit, it will be considered a breach of the Permit thereby giving the County a right to seek and obtain any necessary relief or remedy, including, but not by way of limitation, a judgment for money damages.

With respect to any activities authorized by Permit, when the Community requires insurance on its own or its contractor's behalf, it shall also require that such policy include as named insured the County of Wayne and all officers, agents and employees thereof.

The incorporation by the County of this resolution as part of a Permit does not prevent the County from requiring additional performance security or insurance before issuance of a Permit.

The resolution shall stipulate that the requesting city, incorporated village or township shall, at no expense to Wayne County, provide necessary police supervision, establish detours and post all necessary signs and other traffic control devices in accordance with the Michigan Manual of Uniform Traffic Control Devices.

The resolution shall stipulate that the requesting city, incorporated village or township shall assume full responsibility for the cost of repairing damage done to the County road during the period of road closure or partial closure.

This resolution shall continue in force from this date until cancelled by the Community or the County with no less than thirty (30) days prior written notice to the other party. It will not be cancelled or otherwise terminated by the Community with regard to any Permit which has already been issued or activity which has already been undertaken.

Mr. Roberts indicated about 450 square feet. Mr. Roberts continued that he envisioned that area as a loft use.

Mr. Roberts indicated that he would not live there.

Commissioner Duran stated that the use would mainly be office.

Mr. Roberts stated that is correct. Mr. Roberts continued that since he was a child he loved this building and he wants to restore it and he feels his plans will preserve the flavor of the original building. Mr. Roberts continued that plans on restoring the marquee and will try to keep the majority of the building historic.

Commissioner Lupo asked if he would keep the original sign.

Mr. Roberts stated yes he would like to restore it and his sign would be somewhere on the front of the building.

Commissioner Benson asked Mr. Roberts how many employees would be working for his company.

Mr. Roberts indicated that he would have no more than 5.

Commissioner Tavernier asked about the landscaping around the parking area in the rear.

Mr. Roberts indicated that he would have low growing bushes, it would screen the adjacent properties.

Mr. Tallerico indicated that the Planning Commission is here today for the rezoning only. If and when this gets approved, the appellant would have to come back to this Commission with plans for review and approval.

Mr. Joseph Maher indicated that he is representing the owner in the sale of the property and the property has been in their name since 1906 and the owners are very thrilled with this proposed use. Mr. Maher indicated that the owners pledge their support for this project.

There being no further questions, the public hearing was closed.

No communications were received in favor of this hearing.

#### RE: Proposed Outdoor Café at 2935 Biddle Avenue

Dear City of Wyandotte Planning Commission:

Approved founding Below are responses to the previous open issues. The original statement is followed on the next line by the response.

- 1. Square footage of outdoor seating is very large. Response: This area is large and is solely on private property. It is ancillary to the adjacent restaurant to the south and provides a unique outdoor dining experience that is uncommon in the City.
- 2. Occupancy load is calculated incorrectly on plans, must be calculated as per table 1 OO4.1.2 Pg 243 of the MBC Code 2012. Response: Please see floor plans for adjustments in calculations and clarifications. Previous notes have shown exact
  - seating quantities, the updated plan shows code calculations and clarifications to the occupant loads.
- 3. Document failed to show location and type of fire pits. Also the fire pits are required to comply with 2012 I.F.C. and requires approval of Wyandotte Fire chief and Building Department. Response: The drawings did show the locations of the fire pits in the North West corner of the site, but it appears that the label of "fire pit" was not used. The drawing has been updated and information has been included with this letter. These fire pits do appear in the renderings that were issued. These are currently planned to be linear inserts utilizing LP tanks mounted within a masonry base with accessible door and a granite counter top. 20lbs LP containers will be used at each fire pit table.
- 4. Due to occupant load greater than 50 panic hardware is required at both the front and back gates along with illuminated exit signs at same. Field conditions may warrant emergency lighting. Response: Panic hardware will be provided per code at both exits as well as exit signs. We will explore the potential need for outdoor emergency lighting and our findings and/or specifications will be indicated in the construction documents upon construction permit submittal.
- 5. Provide construction details of outdoor awning system and pergola. Is awning opened or closed above seating area, flammability of materials, height, electrical lighting or heating etc. Response 1: The outdoor pergola will be made from either new or reclaimed timbers and will have the necessary foundation system for supporting the structure and properly bracing the north brick wall. Response 2: The outdoor awning system is currently planned as an open system utilizing 2" structural steel tubing frame and posts while using stainless steel mounting hardware. The fabric awning covering will be a fire resistant or fire retardant material that will meet fire code regulations. A sample and shop drawings will be provide prior to approval and fabrication.
- 6. Provide location of fire extinguishers, minimum of 2A-20BC and maximum travel distance of 75 square feet. Response: Fire extinguishers will be provided per code. The maximum travel distance between 2A fire extinguishers will be 75ft and cover no more than a 3,000sf area as indicated within the fire code. There are no outdoor cooking appliances, but they will be provided within the immediate vicinity of the fire pit tables.
- 7. Property will be required to be combined with adjacent property owned by Applicant at 2935 Biddle Avenue. Response: Please see Certificate of Occupancy included in this clarification packet for the lot combination characteristics.



This correspondence is in response to your e-mail dated Wednesday October 15, 2014 relative to the Outdoor Service application at 2935 Biddle Avenue, Wyandotte, Michigan. I have no objections if the proposal for the outdoor service area is approved as illustrated on the engineering drawings submitted by the applicant, with the following conditions:

- The applicant meets all laws and ordinances as required by the Fire and Engineering Departments.
- Since the proposed outdoor service area is adjacent to the sidewalk area to the front and the alleyway/City Lot #1 to the rear, the license holder must assure that the fencing/barrier at each end of the service area is maintained so there will be no movement of patrons outside of the establishment while in possession of alcoholic beverages.
- Approval is received from the Liquor Control Commission for an Outdoor Café.

Further, the police department recommends that the applicant be reminded that an outdoor service permit allows the sale, service, and consumption of alcoholic beverages in a well-defined and clearly marked area outside of the licensed premises. Compliance with this provision is the responsibility of the licensed establishment and failure to comply could result in the issuance of a violation.
